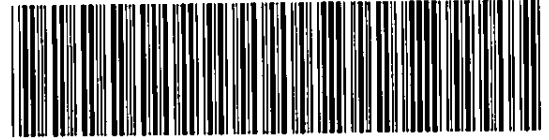

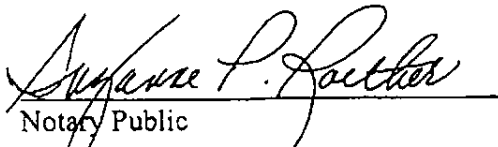

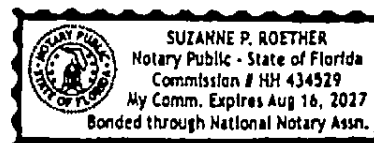
The undersigned, John C. Holt, being duly and severally sworn, deposes and says:
