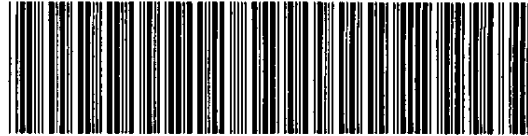


Dear; Board of Directors
