Dear Sir or Madam:

The purpose of writing this letter is to request abatement of the \$400.00 late filing penalty due to reasonable cause. It is my sincere belief that this penalty is the result of reasonable cause on my part and not the intentional disregard of your rules and regulations.

My attorney, J Stephen Pullum has always timely prepared and paid the Corporate Annual Report fees (now the Unified Business Report). His office would then bill Weirview Groves, Inc. for reimbursement. He is the current registered agent so the form was mailed to his office each year. I have always relied upon him to provide this service.

During 2000 Mr. Pullum's office advised me that they were no longer going to provide this service and that all future reports would now be mailed directly to me. This was fine but I never received the report. I did not realize I was late until I was notified by Mr. Pullum's office that they had received a second notice for filing the UBR with the fee now \$550.00.

As you can see the registered agent is still J. Stephen Pullum, which is why I never received the original report. Just as soon as I realized that the agents name & address were wrong I immediately made the appropriate changes and have enclosed a check for \$150.00

It is my sincere belief that the late filing and late payment was all the result of reasonable cause on my part and was not the result of intentional negligence. As a result, please do accept my request to forgive the \$400.00 penalty.
