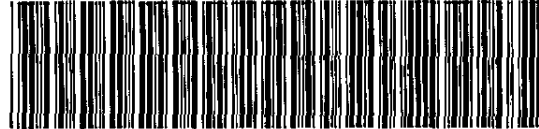

NAME

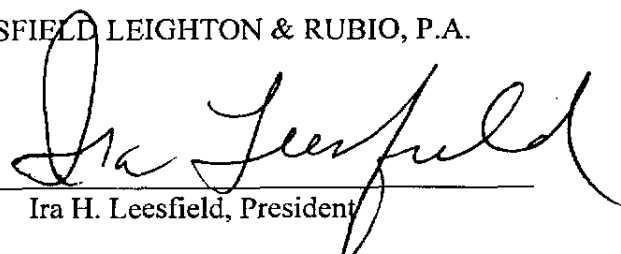
The name of the corporation is Leesfield Leighton & Partners, P.A.

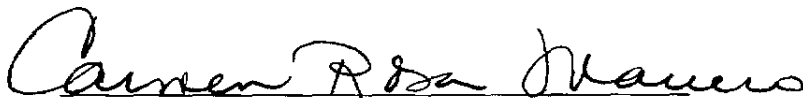
