**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, Robert Hunt Capital Corporation, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

The Articles of Incorporation for the Corporation were filed on May 10, 1979 and assigned Florida Document Number 622375.

**ARTICLE I  
Name**

The name of the Corporation is Robert Hunt Capital Corporation.

**ARTICLE II  
Amendment**
