THESE ARTICLES OF MERGER adopted pursuant to the "Florida Business Corporation Act", to-wit:

1. The undersigned corporations, **BULLDOG WRECKING COMPANY, CITRUS PET CEMETERY, INC., GEORGIA LAND & CATTLE COMPANY, SIR OXFORD, INC., and SUMTER TITLE COMPANY** being validly and legally formed under the laws of the State of Florida, have adopted a Plan of Merger.

2. The name of the surviving corporation is **BULLDOG WRECKING COMPANY**.

3. The Plan of Merger of the undersigned corporations was adopted pursuant to Sections 607.1101, 607.1103, 607.1105 and 607.1106 of the Florida Statutes (1995).

4. The Plan of Merger will become effective upon the filing of these Articles of Merger with the Secretary of State.

5. No changes in the Articles of Incorporation of the surviving corporation have been made.

6. The Plan of Merger was adopted by the Shareholders and Board of Directors of **BULLDOG WRECKING COMPANY** (surviving corporation) on March 13, 1997.

7. The Plan of Merger was adopted by the Shareholders and Board of Directors of **CITRUS PET CEMETERY, INC., GEORGIA LAND & CATTLE COMPANY, SIR OXFORD, INC., and SUMTER TITLE COMPANY** (collectively being the absorbed corporations) on March 13, 1997.

8. The Plan of Merger calls for an exchange of the issued shares which shall be effected as follows: The outstanding shares of each of the five constituent corporations will be surrendered and then five shares for each corporation will be issued in the surviving corporation.




