2. The name of the surviving corporation is **BULLDOG WRECKING COMPANY**.

3. The Plan of Merger of the undersigned corporations was adopted pursuant to Sections 607.1101, 607.1103, 607.1105 and 607.1106 of the Florida Statutes (1999).

4. The Plan of Merger will become effective upon the filing of these Articles of Merger with the Secretary of State.
