



We, the undersigned, President and Vice President/Secretary of the Corporation, do hereby file these Articles of Dissolution of PROPERTY MANAGEMENT OF KEY WEST, INC., a Florida Corporation, pursuant to Sections 607.1402 and 607.1403 of the Florida Statutes.

ARTICLE I - NAME OF CORPORATION

The dissolved Corporation's name is PROPERTY MANAGEMENT OF KEY WEST, INC.

ARTICLE II - DATE DISSOLUTION AUTHORIZED

The Dissolution was authorized on July 25, 2012, pursuant to a Special Meeting of the Corporation's Stockholder and Directors held on July 25, 2012.

ARTICLE III - DISSOLUTION AUTHORIZED BY STOCKHOLDER APPROVAL

The Corporation's dissolution herein was authorized by Stockholder approval pursuant to the procedures set forth in Florida Statutes §607.1402(2)(b), (4) and (5). Pursuant to Florida Statutes §607.1402(5), the Stockholders unanimously approved such Dissolution on July 25, 2012; therefore, the number of Stockholder votes cast for Dissolution was sufficient for approval as required in Florida Statutes §607.1403(1)(c).

ARTICLE IV - EFFECTIVE DATE

Pursuant to Florida Statutes §607.1403(2), the Corporation's Dissolution shall be effective as of the close of business on July 30, 2012, and shall be completed no later than December 31, 2012.

ARTICLE V - ADOPTION OF PLAN OF CORPORATE LIQUIDATION

The Corporation's dissolution was authorized pursuant to a Plan of Liquidation adopted by the Corporation's Directors and Stockholders on July 25, 2012, and the Corporation's Dissolution shall be carried out strictly in accordance with such Plan.


