# PLAN OF MERGER

SMALL CONSTRUCTION, INC., a Florida corporation, and H. L. SMALL CONSTRUCTION CO., INC., a Florida corporation, hereby adopt the following Plan of Merger pursuant to § 607.1101, Fla. Stat. (1995).

 Name of each corporation planning to merge is: SMALL CONSTRUCTION, INC.

and

H. L. SMALL CONSTRUCTION CO., INC.

- 2. Name of surviving corporation is H. L. SMALL CONSTRUCTION CO., INC.
- 3. The terms and conditions of the merger are: See attached Exhibit "1".
- 4. The manner and basis of converting the shares of each corporation is: see attached Exhibit "1".
- 5. The manner and basis of converting rights to acquire shares of each corporation is: See attached Exhibit "1".
- 6. The following are amendments to or a restatement of the Articles of Incorporation of the surviving corporation: The presently existing Articles of H. L. SMALL CONSTRUCTION CO., INC., with all present amendments, if any.

# PROVISIONS FOR PLAN OF MERGER

Terms and Conditions. On the effective date of the merger, the separate existence of the absorbed corporation shall cease, and the surviving corporation shall succeed to all the rights, privileges, immunities, and franchises, and all the property, real, personal, and mixed of the absorbed corporation, without the necessity for any separate transfer. The surviving corporation shall thereafter be responsible and liable for all liabilities and obligations of the absorbed corporation, and neither the rights of creditors nor any liens on the property of the absorbed corporation shall be impaired by the merger.

Conversion of Shares. The manner and basis of converting the shares of the absorbed corporation into shares of the surviving corporation is as follows: Each share of the common stock of SMALL CONSTRUCTION, INC. issued and outstanding on the effective date of the merger shall be converted into 1.15 share of the common stock of H. L. SMALL CONSTRUCTION CO., INC., which shares of common stock of the surviving corporation shall thereupon be issued and outstanding.

Changes in Articles of Incorporation. The Articles of Incorporation of the surviving corporation shall continue to be its Articles of Incorporation following the effective date of the merger.

Changes in Bylaws. The Bylaws of the surviving corporation shall continue to be its Bylaws following the effective date of the merger.



<u>Directors and Officers</u>. The directors and officers of the surviving corporation on the effective date of the merger shall continue as the directors and officers of the surviving corporation for the full unexpired terms of their offices and until their successors have been elected or appointed and qualified.

Approval by Stockholders. This Plan of Merger shall be submitted for the approval of the Stockholders of the constituent corporations in the manner provided by the applicable laws of the State of Florida at meetings to be held on or before February 15, 1997, or at such other time as to which the Boards of Directors of the constituent corporations may agree.

Effective Date of Merger. The effective date of this merger shall be February 28, 1997.

Abandonment of Merger. This Plan of Merger may be abandoned by action of the Board of Directors of either the surviving or the absorbed corporation at any time prior to the effective date on the happening of either of the following events:

- (a) If the merger is not approved by the Stockholders of either the surviving or the absorbed corporation on or before February 25, 1997; or
- (b) If, in the judgment of the Board of Directors of either the surviving or the absorbed corporation, the merger would be impracticable because of the number of dissenting Stockholders asserting appraisal rights under the laws of the State of Florida.
