FLORIDA GENERAL CORPORATION ACT

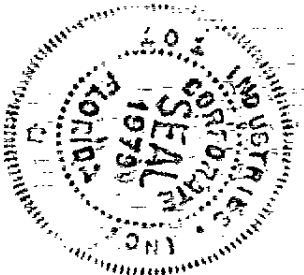
