## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

The undersigned, Eugene Schwartz, certifies that:

- 1. He is the President of Fiveland Investments, Inc., a
  Florida corporation, whose Articles of Incorporation were filed
  with the Secretary of State, State of Florida, on July 31, 1979.
- 2. The following amendment to the Articles of Incorporation was unanimously adopted and approved by the Board of Directors and by the Shareholders, at a special joint meeting, duly called for the purpose of adopting this Amendment and held on November 20, 1997 at 5:30 p.m. at which a majority of the Directors and Shareholders were present and voting thereat.
