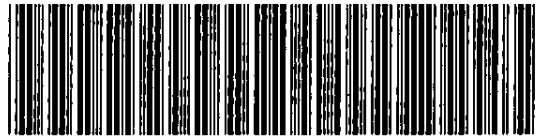


1. The name of this Corporation is **ENVIROSAFE TECHNOLOGIES, INC.**
