2. The Articles of Incorporation of Center for Sports Physical Therapy, Inc. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article:

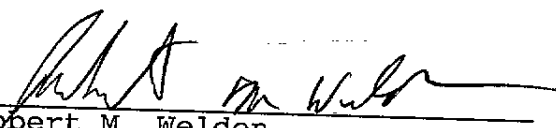
"ARTICLE I.

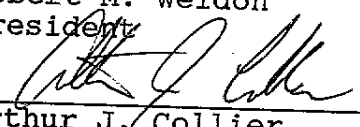
The name of the corporation shall be CSPT, Inc."
