Dear Sir or Madam,

I must say that I was shocked to find the late fee for filing our Annual Report to be \$385.00. It is difficult to believe that anyone in our state government would be any part of such a fee. Our small business has been operating in this state for eighteen years, paying state income taxes, fees, and collecting sales tax. We believe that our record stands for itself in terms of these matters, and we have consistently met our responsibilities in a timely manner.

Certainly our legislators must not know the enormous pressures a small business, such as mine, with only four employees, are currently under. This fee represents a true financial burden to us, and I am in hopes that my mistake this year can be pardoned.

Our current situation is more acute at this time. Our business suffered a fire on May 7, causing complete smoke and water damage to our location. We have since been in the process of moving to a new business site (reference new address above). Due to making an extensive accounting for our insurance and the complications and expenses of attempting to re-open, we are under an even greater financial burden at this time. Though we had neglected filing by May 1, we certainly would have filed by this date had we been aware of the extreme increase in the penalty.

We respectfully request that this penalty be abated for the above reasons, and have enclosed the \$165.00 fee.
