I am sending my report along with the check for the subject document.

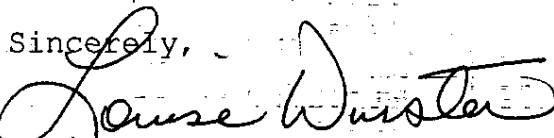
I called your office to advise that I mailed the check on Saturday, April 28, 2001, however, I failed to put the stamp on the envelope and it was returned to me today.
