AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
B T O MANAGEMENT CORPORATION

Pursuant to Section 607.1007 of the Business Corporation Act of the State of Florida, the undersigned, being the Directors of B T O Management Corporation (hereinafter the "Corporation"), a Florida corporation, and desiring to amend and restate its Articles of Incorporation, do hereby certify:

FIRST: The Articles of Incorporation of the Corporation were filed with the Secretary of State of Florida on September 28, 1979, effective September 28, 1979.

SECOND: These Amended and Restated Articles of Incorporation and all amendments to them, were adopted by all of the Directors of the Corporation and approved by the shareholders of the Corporation on October 17, 2018. To effect the foregoing, the text of the Articles of Incorporation is hereby restated and amended as herein set forth in full:

ARTICLE I NAME

The name of the corporation shall be B T O MANAGEMENT CORPORATION.

ARTICLE II PURPOSE

The nature of the business to be transacted is to engage in any activity or business permitted under the laws of the United States of America, the State of Florida and any other state, country, territory or nation.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to have outstanding shall be one hundred fifty (150) shares of common, no par value voting stock.

ARTICLE IV TERM OF EXSTANCE

The duration of this corporation shall be perpetual.

ARTICLE V ADDRESS

The principal office of this corporation shall be at 518 Industrial Ave., #2, Boynton Beach, Florida 33426.

ARTICLE VI DIRECTORS

There shall be not less than one or more than seven Directors of this corporation, provided, however, that the number of Directors may be increased in any manner now or hereafter authorized by law.

ARTICLE VII INDEMNIFICATION

Each person who at any time is, or shall have been, a director or officer of the Corporation, and is threatened to be or is made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that he or she is, or was, a director, officer, employee or agent of the Corporation, or is or has served at the request of the Corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, shall be indemnified against expenses (including attorneys' fees, which may be advanced as provided under Section 607.0850 of the Florida Business Corporation Act), judgments, fines and amounts paid in settlement actually and reasonably incurred in connection with any such action, suit or proceeding to the full extent permitted under Section 607.0850 of the Florida Business Corporation Act, as from time to time amended. The foregoing right of indemnification shall in no way be exclusive of any other rights of indemnification to which such director, officer, employee or agent may be entitled, under any bylaw, agreement, vote of shareholders or disinterested directors or otherwise, and shall continue as to a person who has ceased to be a director, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of such a person. The Board of Directors of the Corporation may authorize the Corporation to purchase and maintain insurance on behalf of any person who is or was a Director, officer, employee or agent of the Corporation, or is or was serving at the request of the Corporation as a director, officer, partner, employee or agent of another foreign or domestic corporation, partnership, joint venture, trust or other enterprise, against any liability asserted against such person and incurred by such person in any such capacity or arising out of his or her status as such.

ARTICLE VIII CERTAIN LIMITATIONS ON LIABILITY OF DIRECTORS

Except to the extent that the Business Corporation Act of the State of Florida prohibits the elimination or limitation of liability of directors for breach of the duties of a director, no director of the Corporation shall have any personal liability for monetary damages for any statement, vote, decision, or failure to act, regarding corporate management or policy. No amendment to or repeal of this provision shall apply to or have any effect on the liability or alleged liability of any director of the Corporation for or with respect to any acts or omissions of such director occurring prior to such amendment.

ARTICLE IX RESTATEMENT

The intention of the restatement of these Articles of Incorporation are that they shall supersede in their entirety the original Articles of Incorporation and all amendments thereto.
