I would like to request that you accept this reinstatement application and waive the \$300 penalty. The reason for the request is that the owner of the company, Rosa Lugo was robbed at gunpoint in Miami outside of her business in the beginning on May, 2009. The men who robbed her had followed her from her Wachovia Bank branch and she was carrying her briefcase with her business checking accounts in it and some cash. They took her purse, briefcase and car. She contacted the bank right away and they closed her account and open new accounts for her.
