ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPOR

OF

GILLILAND INSURANCE AGENCY, INC.,

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to the Articles of Incorporation:

- 1. The name of the Corporation is GILLILAND INSURANCE AGENCY, INC.
- 2. Article IV of the Articles of Incorporation of the Corporation is hereby amended in its entirety to provide as follows:

"ARTICLE IV - CAPITAL STOCK

The aggregate number of shares of stock which the corporation shall have authority to issue is Five Hundred (500) shares of common stock, with a par value of One Dollar (\$1.00) per share."
