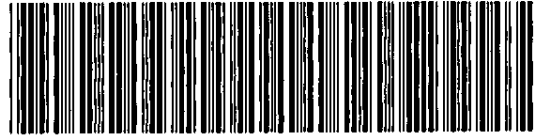

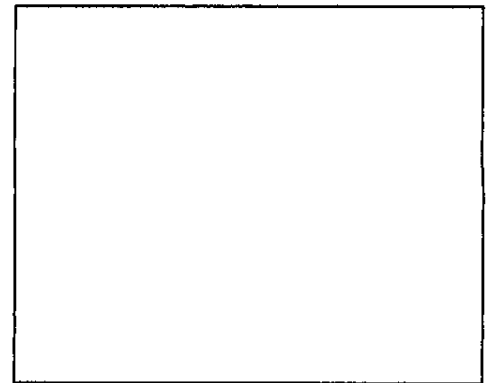

AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
GENERAL CONTRACTING AND CONSTRUCTION CO., INC.

The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of GENERAL CONTRACTING AND CONSTRUCTION CO., INC.

1. The name of the Corporation is currently GENERAL CONTRACTING AND CONSTRUCTION CO., INC.
2. The date of the filing of the Articles of Incorporation was August 10, 1979 and assigned Document No. 640314.
3. The Articles of Incorporation are amended as follows:
 - a. By deleting all of Article III, Capital Stock of the Articles of Incorporation, and by substituting in lieu thereof, all of the following:

“ARTICLE III – CAPITAL STOCK

The maximum number of shares of stock of this corporation that may be issued is 1,100, consisting of 100 voting common shares having a par value of \$1.00 per share and 1,000 non-voting common shares without par value. Each class of shares shall be identical in all respects, except that the non-voting shares shall carry no right to vote for the election of directors of the corporation, and no right to vote on any matter presented to the shareholders for their vote or approval except only as the laws of this state require that voting rights be granted to such non-voting shares.”

- b. In all other respects, the Articles of Incorporation shall remain unchanged.
4. This Amendment was adopted by a written statement signed by the sole shareholder and director of GENERAL CONTRACTING AND CONSTRUCTION CO., INC. on the 21 day of December, 2011, pursuant to Section 607.1003 of the Florida Statutes.


