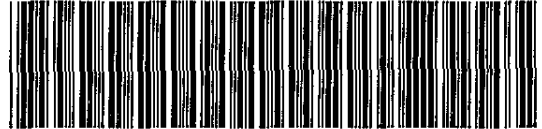

Reiss, Kang & Burks, M.D., P.A.


