

To Whom It May Concern:

Re: William Zeigler Properties, Inc. Document # 642424

Pursuant to my several telephone conversations with your department between April 26, 1997 and September 30, 1997, I have finally been able to confirm an "FEI" number from the Internal Revenue Service Office in Atlanta, Georgia. I want to assure your department that I have exhausted every effort possible to secure the information required of us. To this end, the following steps have been taken from March to September, 1997.

- 1. Between March I and about April 27, 1997, I called the IRS at the number listed on the Annual Report Form to determine if an FEI number for the above named corporation was listed with them. It was my thinking that if we had originated corporation status in 1979 (initiated by Willie Zeigler White now deceased in 1982) and resumed in June, 1996 by Stanley Z. White, Vice President, it would seem only logical that an "FEI" number would be in existence. In spite of this IRS agents continued to respond with a "no" and no further information or assistance was provided.
- 2. In order to meet the May 1, 1997 deadline for filing the Annual Report, I mailed the report by identifying myself as Secretary of the Corporation with my Social Security Number.
- 3. When the report was returned to me in mid May, 1997 requesting the same information in Block 4 ("FEP" Number), I immediately repeated the original steps of contacting IRS. From the outset there were two pieces of information that I always provided when talking to IRS the name of the corporation, and the original date of incorporation.
- 4. The next step for me was to work backwards and contact the Corporation Vice President, Stanley Zeigler White, who orchestrated the reinstatement in June, 1996. His records showed no evidence of an "FEP" number for the William Zeigler Properties, Inc.
- 5. Continuing my search, I contacted the Department of Corporations by telephone to notify them that I'd had no success in obtaining the "FEI" number. I talked to a representative in your department who identified herself as "Trevor". Trevor listened to my account of the efforts I had expended as listed in items 1-4 above. She was very helpful and positive to the extent that she advised me to call the IRS again and not to hang up the telephone until someone had explained to me thoroughly the process for acquiring an "FEI" number.
- 7. I called IRS again at the same number, repeating the two major pieces of

information - the name of the corporation, and the original date of incorporation. (I also indicated the number of times that I had called before this time). The IRS agent who identified himself as "Les" told me that I needed an SS-4 Form. To expedite matters, he told me that I could pick up such a form at the Federal Building here in New Jersey. He told me to complete this SS-4 Form, call in the information to IRS and at that time they would assign us an "FEI" number over the telephone and then I should mail the form in to IRS at which time the "FEI" number would be affixed in writing by the IRS. This conversation took place on September 26, 1997.

On September 30, 1997, after acquiring and completing the SS-4 Form, I called IRS again as directed to secure an "FEI" number that I might forward to your office. When I got to numbers 17Å, B, and C on the SS-4 Form (a copy enclosed) the IRS agent asked me to hold for a moment. When she returned to the phone she said that she would give me another number to call and someone there may be able to assist me better. The number she gave me was (770) 455-2360 which I later found to be an IRS office in Atlanta, Georgia. I called the number given to me and spoke to an agent who identified herself as "Toni". When I related the information to her from numbers 17a, b, and c on the SS-4 Form, she stated, after looking up some information, that an "FEI" number had been assigned to the "William Zeigler Properties, Inc." in 1979. That number (59-1982532) now appears in Block 4 on the "Annual Report Form." The Atlanta, Georgia agent did request that a copy of the "Articles of Incorporation" be sent to her office as soon as possible. I am prepared to do so immediately.

Having exhausted efforts that were apparently subject to misinformation, or even more, no information by IRS over a period of approximately five (5) months, I, herein, plead for the understanding of your department to "waive" the additional fee of \$550.00 for my inability to supply an "FEI" number upon request.

I take this opportunity to thank you in advance for any consideration that you may give to this request.
