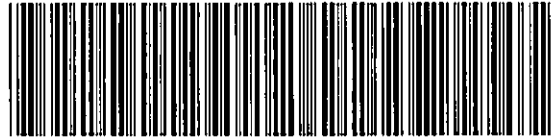

ARTICLES OF INCORPORATION
OF

1. The name of the Corporation is CHARLES M. WATTS AIR CONDITIONING, INC.

2. The Corporation was formed as a corporation under the laws of the State of Florida by the filing of Articles of Incorporation (the "Articles") with the Florida Department of State on October 25, 1979, under filing number 642999.

4. The foregoing amendment to the Articles of the Corporation was approved by the Corporation's board of directors and the Corporation's sole shareholder on December 13, 2024.


