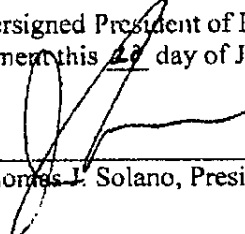
**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
INFORMATION SYSTEMS OF FLORIDA, INC.
(Document No. 644584)**

This Corporation was incorporated on November 8, 1979. Pursuant to Sections 607.1001, 607.1003, 607.1004 and 607.1006, Florida Business Corporation Act, an amendment to Article IV of the Articles of Incorporation, as amended from time to time, was approved by unanimous written consent of the Board of Directors effective July 22, 2015, and adopted by the written consent dated July 22, 2015 of shareholders owning a majority of the corporation's outstanding voting stock. The only voting group entitled to vote on the adoption of the amendment consists of the holders of the Corporation's common stock. The number of votes cast by such voting group was sufficient for approval by that voting group. Article IV of the Articles of Incorporation of the Company is hereby amended in its entirety to read as follows:

"Article IV – Capital Stock. This corporation is authorized to issue four million and five hundred thousand (4,500,000) shares of stock, having a par value in the amount of \$0.005 per share, which shall be designated 'Common Shares.'"

This amendment shall be effective upon filing with the Florida Department of State.
