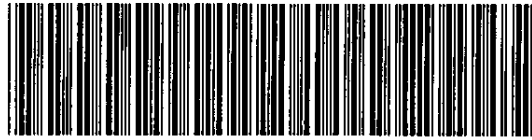



3. The effective date for dissolution is the date these Articles of Dissolution are filed with the Florida Department of State.

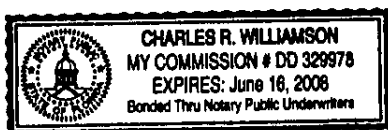
