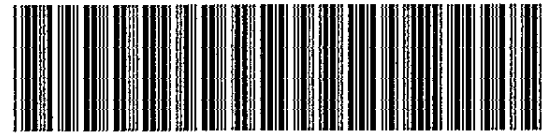

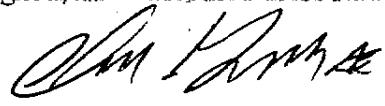

Pursuant to Florida Statute Section 607.1006, the Articles of Incorporation for the above named corporation are hereby amended as follows:

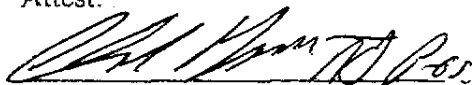
1. The name of the Corporation is **LOC PUMP & CONTROL, SERVICE AND RENTAL, INC.**
