WHEREAS, the Directors and owners of all the common stock of VIRSHUP AND SCHWEITZ, M.D., P.A., a Florida corporation, did unanimously approve at a meeting of the shareholders and directors held on December 17, 1997, subject only to approval thereof by the Secretary of State, State of Florida, amending Articles I and II of its Articles of Incorporation for the purpose of changing the name of the corporation and amending the provision relating to the purpose of the corporation.
