- a. Article I, be and it hereby is amended to read as follows:

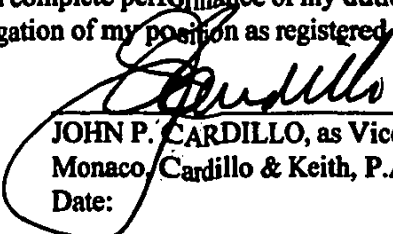
Effective January 1, 1997, the name of the corporation shall be:

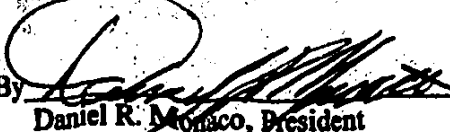
2. The foregoing amendments were adopted by the Stockholders and Directors of the corporation on the 28 day of December, 1996.
