
Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:


FIRST: Amendments adopted: **Article I Name:** is hereby amended to read, The name of this corporation is First City Funding Corp.



BEFORE ME, personally appeared, HAROLD M. MALIN, who after being duly sworn by me deposes and states:


