The Articles of Incorporation are hereby amended to read:

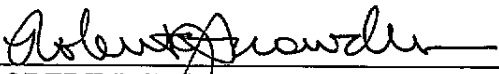
1. The name of this Corporation shall be REALTY ASSOCIATES OF KEY WEST, INC., a corporation organized under the statutes of the State of Florida.

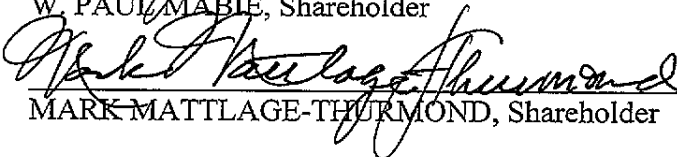
