ARTICLES AND PLAN OF MERGER OF 1366 CARONDELET STREET CORP. AND KINGS GARDENS HOMES,

WE, the undersigned, being respectively the President and Secretary of 1366 Carondolet Street Corp. and Kings Gardens Homes, Inc. hereby certify:

- The names of the constituent corporations are 1366 Carondolet Street Corp. a
 Louisiana corporation and Kings Gardens Homes, Inc., a Florida Corporation being
 the surviving corporation in the merger and its name as the surviving corporation is
 Kings Gardens Homes, Inc.
- On the effective date of the merger, the Articles of Incorporation of Kings Gardens
 Homes, Inc. shall be the Articles of Incorporation of the surviving corporation until
 further amended as provided by law.
- 3. On the effective date of the merger, the By-Laws of Kings Gardens Homes, Inc. shall be the By-Laws of the surviving corporation until the same shall be altered, amended or repealed, or until new By-Laws shall be adopted, in accordance with the provisions hereof.
- 4. The merger provided for herein shall become effective at the close of business on the date it is filed by the Secretary of State.
- 5. The plan of merger was adopted by the Directors and Stockholders of 1366
 Carondolet Street Corp. and Kings Gardens Homes, Inc. special joint meetings called to consider and vote upon the merger held on, November 13, 1998.

- 7. The Officers of Kings Gardens Homes, Inc. on the effective date of the merger, shall continue to be the Officers of the surviving corporation and shall hold office until their respective successors are chosen and qualified, as provided by law and the By-Laws of the surviving corporation.
- 8. Each share of common stock of Kings Gardens Homes, Inc. outstanding on the effective date of the merger, shall remain outstanding as one (1) share of common stock of the surviving corporation. On the effective date of the merger, all shares of 1366 Carondelet Street Corp. shall be cancelled and all rights in respect thereof shall cease.
- 9. On the effective date of the merger, all of the property, rights, privileges, and franchises, of whatsoever nature and description of 1366 Carondolet Street Corp. shall be transferred to, vested in and all property rights, privileges and franchises shall be the property of Kings Gardens Homes, Inc.
