Pursuant to Section 607.1008(1) of the Florida Business Corporation Act, the Articles of Incorporation of **KELLSTROM SOLAIR, INC.**, a Florida corporation, hereafter referred to as the "Corporation," are amended to read as follows:

The First Article of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety to read as follows:

"FIRST: The name of the Corporation is KC-I, Inc."

Except as provided for above, the Certificate of Incorporation of the Corporation shall remain unchanged.

The foregoing amendment to the Articles of Incorporation of the Corporation was duly authorized and adopted by the Corporation's Board of Directors and by the sole Shareholder of the Corporation as of the 17th day of July, 2002.
