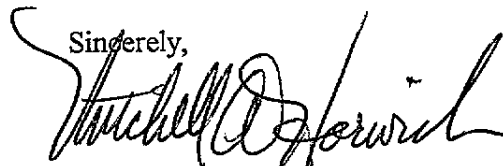

SECOND AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

EDWARD A. CAVA, M.D., AND ROBERT C. CAVA, M.D., P.A.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Second Amendment to its Articles of Incorporation:

Article I. of the Articles of Incorporation is hereby deleted and the following is inserted in lieu thereof:

"ARTICLE I. NAME
