Pursuant to Section 607.181 of the Florida General Corporation Act, CAC Properties, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. It is deemed in the best interest of the Corporation to change its name to "CAC Medical Centers, Inc."
2. The Board of Directors and the sole shareholder of the Corporation have adopted the amendment to the Articles of Incorporation below in accordance with Section 607.181(3) of the Florida General Corporation Act, by separate written actions dated June 23, 1997.
