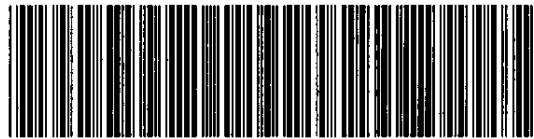



TO THE ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of law, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE NINETEEN




