The Taxpayer never received the original (U B R) Annual Report or would have filed timely as in the past.

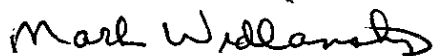
The Corporation's Stockholders were involved in a fight amongst themselves for control of the Corporation.
