1. The name of the corporation prior to this Amendment is **DIAMOND INFORMATION SERVICE, INC.**

2. This Amendment changes the name of this corporation to **LAWRENCE E. LEVIN, INC.**, and therefore old Article I of the corporation's Articles of Incorporation is hereby deleted and new Article I is added and shall read as follows:

"ARTICLE I

NAME

The name of this corporation is **LAWRENCE E. LEVIN, INC.**"

3. The foregoing Amendment was adopted by the board of directors of the corporation and by the Shareholders of the corporation on April 5, 1995.
