Pursuant to the provisions of Chapter 607 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Bell Signs, Inc.

SECOND: The following amendment of the Articles of Incorporation of the Corporation was adopted by all of the Stockholders and Directors of the Corporation effective on July 30, 1999, in the manner prescribed by the Florida Statutes:

"The Articles of Incorporation of the Corporation are amended by deleting Article III of the Articles of Incorporation and substituting in lieu thereof the following new Article III:

"ARTICLE III - CAPITAL STOCK

"The aggregate number of shares which the Corporation is authorized to issue is five hundred thousand (500,000) shares of Common Stock having a par value of One Cent (\$0.01) per share, such common stock being all of one class and bearing one vote per share which vote shall be noncumulative."
