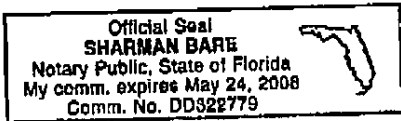
- (1) The name of the corporation is LAKELAND UROLOGY, P.A.

- (3) The dissolution was approved by the written consent of the sole Shareholder and Director of the Corporation.


