Thank you for your letter of August 7, which arrived today, and particularly for specifying that the only provision for a waiver of the \$400 late fee is if the annual report form was not received.

Certain points were made in my letter of July 25 (copy enclosed) but, being unaware of this provision, it was not used as the underlying cause of apparently became a "late matter".

For the past few years, as stated, we used the web-site for on-line filing, and making any changes. Since I was out of State and left checks here to be filed in time, but also since there was no notice/filing forms were sent here for me to sign prior to leaving, the person mailing the checks prior to deadline did not have the forms to file with the payment and only sent the checks..

This required the Corporation Division to forward forms for signature and for any changes, including a third corporation that required signatures and the registered agent area completed. All was sent back within the required time. (The third corporation received an acknowledgment of reinstatement)

Had our office received the notice/forms, and they could be signed at the time the checks were originally sent on time, a late fee would not be necessary.

Our record for the past 59 years for one; 28 and 26 years for the other two shows that we have always been prompt in returning the forms and paying the fees, and had the notice/forms been sent for signature this year, they would not have been sent without the proper forms.
