Dear Ms. Milligan:

Thank you very much for taking the time to speak with me on November 8th. I very much appreciate your assistance with this matter. Please find enclosed a copy of the UBR with the signature on line 8 crossed out and signed on line 13 as you requested.

As we discussed on the 8th, the original UBR for my client was mailed on time in May of 2000 (please find enclosed a copy of the UBR, along with all other documents mentioned hereunder). However, my client had inadvertently signed on the wrong line. As she is a resident of Colombia, time restraints precluded us from drafting a new UBR. A letter was sent explaining this requesting that the signature on line 8 be accepted. We never received any word from the Department until the \$150 check for the annual fee was cashed in May. After that had occurred, we presumed that the signature was acceptable.

However, in September we received a notice that the corporation was dissolved. In response, we drafted another letter asking why when we never heard a negative response from the Department after sending in our explanation and having the check cashed. The Department's response to this letter stated that the Annual Report was rejected in June of 2000 and that we did not provide a response within thirty (30) days of such ruling. However, we never received any notification that the Annual Report was

rejected, nor were we informed that we had an opportunity to cure the defects. Had we known, we would have immediately done so.

I hope that this explanation is satisfactory and that the amended UBR satisfies all requirements to avoid any reinstatement fee. If you have any questions, please feel free to contact me at 561-439-5500.
