**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
THE CREATIVE PRINTING PLACE, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, **THE CREATIVE PRINTING PLACE, INC.**, a Florida profit corporation (the "Corporation"), adopts the following amendment (the "Amendment") to its Articles of Incorporation:

1. The name of the Corporation is **THE CREATIVE PRINTING PLACE, INC.**
2. The Articles of Incorporation were filed on July 18, 1980 and assigned document number 679751.
3. Article VII of the Articles of Incorporation of the Corporation is hereby amended by deleting it in its entirety and replacing it with the following:


**"ARTICLE VII**

This corporation shall have the number of directors as may be elected from time to time by the shareholders of the corporation and in accordance with the Bylaws, but in no event shall the number of directors be less than one (1)."

4. This Amendment was adopted on February 1, 2021.
5. This Amendment was duly and unanimously adopted and approved by the shareholders of the Corporation. The number of votes cast for the Amendment by the shareholders were sufficient for approval.
6. Except as amended hereby, the Articles of Incorporation of the Corporation shall remain in full force and effect.
