1. The Amendment to the existing Articles of Incorporation being effected hereby is that resulting from completely deleting Article I of the Articles of Incorporation and substituting in its place the Article set forth below, the sole effect of such amendment being to change the Corporation's name from "SESSUMS & MASON, P.A." to "SESSUMS MASON & BLACK P.A."

2. This Amendment to the Articles of Incorporation was approved by written consent of all of the stockholders of the Corporation, adopted on the 31<sup>st</sup> day of January, 1997, pursuant to Section 607.1003(6), Florida Statutes, and the number of votes cast for the amendment by the stockholders was sufficient for approval.

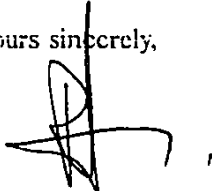

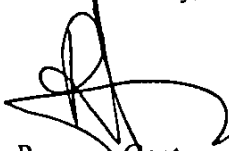
