As per conversation, I am attaching a copy of both Charmatt and Frontier's Annual Reports and two (2) checks in the amount of \$158.75 each. It is rather confusing, but I will try to explain to you what has transpired.

As I mentioned to you our check was originally written for the \$300.00 to cover both companies. Apparently, someone mistakenly thought we overpaid ONE account, when in fact, it was for two companies..thus returned the check to us. Therefore, I wrote a letter and re-sent a check again on July 3, 1998.

On July 9, 1998 we received a second notice upon which I immediately checked with our accountant, my records to see if the check had cleared, when it was mailed, etc. I called your office at 850-487-6050 and spoke to Richard at 9:45a.m., on July 14, 1998. He told me that I needed to re-direct my letter to a different address (PO Box 6327, not POBox 1500) and questions to your office.

In the meantime, we received back again the check and a notation that it was the wrong amount for Frontier Construction. No mention or paperwork returned for Charmatt, Inc. This time we were told to add a penalty fee. We had asked previously to waive this penalty.

We have paid our annual report fees on time, if not early, for the past 21 years. We had also paid both companies on one check.. so this is a "first" for us. We ask that you take this into consideration. It is unfortunate that this has turned into such an ordeal and as discussed with you, we will in the future write "Two" separate checks instead of one to cover both companies. I sincerely apologize for the confusion this has created. I did have another Annual Report Form for Charmatt, Inc. that was sent to us when the second notice was mailed and I am completing it and sending it to you. We are also requesting the certificate for the \$8.75 in case of any future discrepancies.
