ARTICLES OF AMENDMENT OF
THE ARTICLES OF INCORPORATION
OF
CHRIS-MARINE USA, INC.

- A. The name of the corporation is Chris-Marine USA, Inc. (the "Corporation").
- B. The Articles of Incorporation were filed with the Florida Secretary of State on August 20, 1980.
- C. An amendment to the Articles of Incorporation was adopted on July 17, 2006, by the shareholder and sole member of the Board of Directors of the Corporation to amend Article 1 of the Articles of Incorporation in its entirety as follows:

"Article 1. Name

The name of this Corporation is Worldwide Diesel Power, Inc."

There are no other amendments to the Articles of Incorporation, except as stated above.

- D. The shareholders of the Corporation were entitled to vote on this amendment, and the number of votes cast for the amendment was sufficient for approval by the shareholders.
