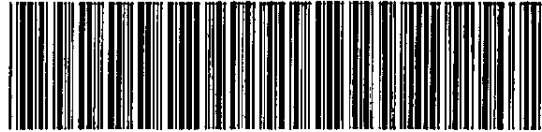

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
WILBEY INDUSTRIAL SERVICE CORPORATION**  
(A Florida Profit Corporation)

Wilbey Industrial Service Corporation (the "Corporation") desires to amend its Articles of Incorporation, and pursuant to Florida Statute 607.1006, submits the following:

**FIRST:** The Articles of Incorporation were filed on August 28, 1980, and were assigned document number 685861.

**SECOND:** The following amendments to the Articles of Incorporation were adopted by the Corporation:

ARTICLE VI of the Articles of Incorporation shall be deleted and replaced in its entirety by the following ARTICLE VI:

ARTICLE VI

This corporation shall have a Board of Directors. The business of this corporation shall be managed by, and its corporate powers exercised by, its Board of Directors.

The following ARTICLE VIII is hereby added to the Articles of Incorporation:

ARTICLE VIII

The Board of Directors for this corporation shall consist of not less than one and not more than three members, the exact number of the same to be fixed by the stockholders or by this corporation's bylaws. Each member of the Board of Directors shall have attained the age of majority. A quorum for the transaction of business shall be as determined by the members of the Board of Directors from time to time, and as provided for in the bylaws of this corporation. Subject to the bylaws of this corporation, meetings of the Board of Directors may be held within or without the state of Florida. Members of the Board of Directors need not be stockholders. The stockholders of this corporation may remove any member of the Board of Directors from office in accordance with the bylaws of this corporation.

**THIRD:** The aforesaid amendments were adopted on 27 December, 2004.

**FOURTH:** The aforesaid amendments were approved by the shareholders and by the board of directors. The number of votes cast for the amendments by the shareholders and by the board of directors was sufficient for approval.

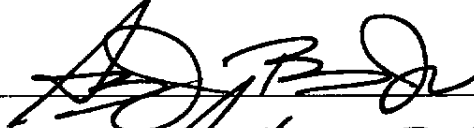
