ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF

Pursuant to the provisions of §§607.1001 and 607.1006, Fla. Stats., the undersigned, MARCO ELIAS QUINONES, being the President, of PLANNING BUS LINE, INC., hereby adopts the following Articles of Amendment to its Articles of Incorporation:

1. The current name of the Corporation is PLANNING BUS LINE, INC.

2. The following is the Amendment to the Articles of Incorporation of the Corporation, which has been adopted, to-wit:

"Article I, which relates to the name of the Corporation, is hereby amended to read as follows:

"ARTICLE I
