The name of the Corporation is SCOTT SIGN SYSTEMS PACIFIC, INC.

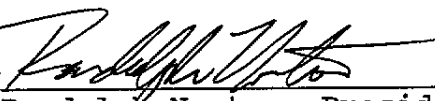
ARTICLE II - RESOLUTION TO DISSOLVE
