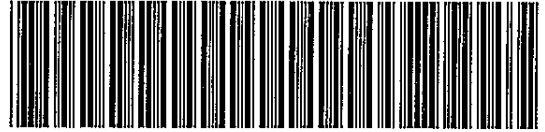

ARTICLE II



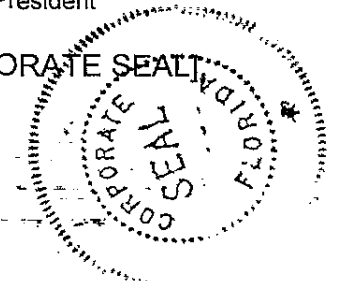
