Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned, for and on behalf of Jax Utilities Construction Company, Inc. (the "Corporation"), hereby adopts the following amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Jax Utilities Construction Company, Inc., whose document number is 688783.

SECOND: The amendment to the Corporation's Articles of Incorporation affected by these Articles of Amendment is that Article I is amended and restated as provided below:

"Article I

The name of this Corporation is URC Caribbean, Inc."
