**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
MAVCO, INC.

Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of MAVCO, INC., a Florida for profit corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

SECOND: "Article 1" of the Articles of Incorporation is amended in its entirety to read as follows:

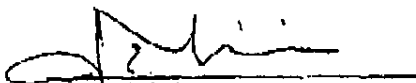
"ARTICLE I
